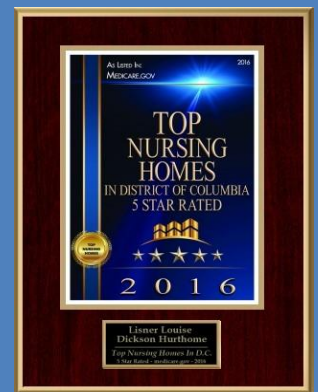

Today, the Home offers a wide range of personalized short-term, long-term, and rehabilitative care to a diverse population of 100+ women and men within the comfortable, private surroundings of its historic residence in Washington, D.C.
